### Footnotes

CREA'S LAW broke in at the start bumping lightly with DAVINS TICKET, settled three wide in pursuit initially midpack, ranged up three wide at the three-eighths to pressure the front, came under a drive nearing the quarter pole, took command straightening away, inched clear through the final furlong appearing to be trying to get in as the rider used the off side rein to correct it while remaining under a drive to the wire. DAVINS TICKET bumped lightly at the start, was coaxed along from just off the inside in the two path towards the rear, advanced on the front swinging three wide for home, offered up mild kick through the lane for the place honors. ALTERNATIVE broke a bit awkward appearing to slip a bit at the start, chased inside at the rear until shifting to the three path approaching the midway point on the turn, spun five wide in upper stretch, kicked home belatedly for the show honors. KELTIC FIGHTER tracked inside well held early on in behind a trio through the turn unable to extract himself off the inside, appeared to want to angle out at the quarter pole and was forced to wait as DAVINS TICKET went by, came under urging in behind, took a bad step at the eighth pole bobbling, was protected from that station to the wire. HOUSE OF LEAVES set a pressured pace inside joined by HOOKDONCHURCHPUNCH, then was accompanied from the three-eighths pole by the eventual winner who ranged up to intensify the pace, came under a ride at the five-sixteenths, got displaced on the lead straightening for home and steadily faltered through the lane. HOOKDONCHURCHPUNCH hustled from the start, pressed the pace two to three wide through the turn, faded in the latter portion approaching the quarter pole, swung four wide at that juncture and tired.
