GENERAL MAXIMUS assumed a forward position after the start, stalked the leader towards the two path, was asked for a response prior to reaching the quarter pole, shadowed the pacesetter outward slightly heading into the stretch, made little progress during the initial portion of the stretch run, gained ground more readily thereafter, drew abreast of DR DISCO in the vicinity of the sixteenth pole, took over a few strides later and edged away under good handling. DR DISCO took charge a short distance from the gate, set a lively opening half while placed at a slight distance from off the rail, drifted out a bit turning for home and got called upon, felt the winner's presence with about a sixteenth to go, relinquished soon afterwards but continued on with good courage to garner place honors. MINESWEPT rated in the two path until upper stretch, rallied to grab the show. DRIVEN BY SUCCESS got out hustled for command, tracked the pacesetter taking the inside route, tugging noticeably on the left side of the bit during the run around the bend, came up empty for the stretch run. LAW ENFORCEMENT lacked the necessary stretch response. SMOKIN HERO was steadied at the start, got placed five at the head of the stretch, failed to muster up a solid closing punch. BE BULLISH gave chase from the two path and tired. PREACHINTOTHEDEVIL underwent a three wide pursuit, folded. PRETTY BOY FREUD outrun for the opening, swung six wide into the lane, had no offering to render.
