DRIVEN BY SUCCESS set the pace on the rail into upper stretch and drew off under steady urging. LEGAL CONSENT was outrun for a half after checking the start and rallied along the rail to gain the place. CITIFEST gained on the turn while saving ground, made a run to threaten in midstretch and finished evenly. MR. WINDJAMMER raced inside to the turn, angled out in upper stretch and improved his position with a mild late rally. DR. W was outrun for a half and rallied mildly. SMOKIN HERO raced up close along the rail into upper stretch and tired. GOODANDACCEPTABLE was used up dueling for the early lead. BE BULLISH chased four wide to the turn and tired. TOO TOUGH PETE was never a factor. LAW ENFORCEMENT was outrun. LOOKIN AT HER faded after going a half.
