Footnotes

GO GET THE BASIL underwent a three wide pursuit, picked up the pace prior to spinning into the stretch, drew even with the runner up in the vicinity of the sixteenth pole, took over a few jumps later and shook free. LEILANI'S TICKET disputed the pace from the two path for nearly a half, felt the winner's presence coming to the end of the furlong grounds, felt it even more so as that opponent drew on dead even terms a sixteenth down the road, relinquished in short order but continued onward to remain well clear of the others for second. JEREK DETER raced from the outside and proved no match for the first two finishers en route for the show. ZEDDEMORE argued for the lead from along the inside just short of going a half before giving way. NO NUKES was bumped after the start, felt the whip several times proceeding down the backstretch but remained indifferent, began to improve position during the run around the turn, was under strong handling taking the four path for entrance into the stretch, made no impact. SATURDAY APPEAL broke inward, bumping lightly with NO NUKES then stumbling after the contact, raced at a considerable distance from off the front runners throughout the opening half, was five

wide at the head of the stretch, had no rally. SHIMMY COCO PUFF raced along the outside and was outrun. G W'S HAMMER took the inside route, was put to a prolonged drive to no avail. CAJUN BEST grabbed hold after being forced inward to avoid making solid contact with NO NUKES, was never in contention. SLIMSHADY chased the pace combatants for a half and tired. PATRIOTIC DUTY angled off the inside in the vicinity of the five-sixteenths pole, folded.
