**Footnotes**

RUTHENIA sat reserved within striking distance from the outside for nearly three-quarters, crept up a bit closer nearing the quarter pole, remained on hold, briefly awaiting further developments, availed of an opportunity to angle three wide into the stretch, altered course outward even more in the vicinity of the three-sixteenths pole for optimal racing clearance, closed in readily during the run through the furlong grounds, drew on even terms with EXCITED at the sixteenth pole, poked a head in front a few jumps later and edged clear under good handling. EXCITED strung out three wide around the opening bend, proceeded to enter the second turn from the same path, bided time before tipping into the four path at the five-sixteenths pole, rallied in earnest under encouragement turning for home, narrowed the gap with good determination, collared the lead to be in front briefly, was soon collared herself by the top one, reluctantly yielded soon afterwards, but continued on stubbornly to preserve the place. SPEEDY'S GAL three wide during most of the way around the far turn, angled a bit wider into the stretch and displayed a good kick down the center of the course en route for the show. SUBPOENA came off the hedge to clear a tiring foe coming to the half mile pole, then rallied belatedly for the final major slice of the purse. STREET CHIMES contently tracked the leader from the pocket under a snug hold, came up empty when called upon in the stretch. MOUNT HOLIDAY bobbled at the break, dropped quickly towards the back of the pack, mustered up enough stretch energy to improved position by mainly weak and tired rivals. UPPER EAST SIDER rated stalking the pacesetter from the three path, steadily tired after going six furlongs. ROSA SALVAJE rated prompting the leader from the outside until the quarter pole, had

nothing to offer leaving the furlong grounds. ARTIE'S PARTY set the pace while being rated along the hedge until the quarter pole before giving way. THUNDER JEWEL saved ground, was through after going a half, drifted very wide into the stretch, was eased by the eighth pole and protected the remainder of the way.
