TRES' MAUVE came through inside a pair of rivals to vie for the lead leaving the half mile marker, kicked clear on the turn, maintained her advantage to the final furlong and was fully extended late to hold sway. SPEEDY BUSTER saved ground advancing to contention on the turn, angled outside of the winner in midstretch, finished willingly and just missed. HEATHER ON raced within range in midpack from the two path to the stretch, finished with interest. SO SOFT SUZY raced in midpack along the rail to the stretch and had a mild rally. BECAUSE OF CANDY raced five wide around the turn and failed to threaten. BLUSHING CALLER raced three wide in midpack to the stretch and did not rally. REGAL MARIA showed little. LAUGHING ROSE trailed to the stretch while being outrun and passed only tired rivals through the lane. BONAFIDE LADY was outrun. P. B. AND J. flashed brief speed to vie for the lead from the two path on the backstretch, chased to the lane before tiring. SAVANNAH BLUFF raced close up while three wide to the stretch, tired. DECORATED AT DAWN flashed brief speed racing off the inside on the backstretch before retreating on the turn.
