BRINKER rated just off leaders to the final turn, rallied into stretch. split horses and drew off under a steady drive. POWER OF ATTORNEY had good speed, set pace to deep stretch from inside but could not hold off the winner while no match late. WEST LONG BRANCH chased leader to the stretch but faltered in the drive. CINNAMON COWBOY raced evenly and lacked a late response when needed. CRYPTO'S PROSPECT failed to menace. VINQTIEME raced four wide down the backstretch and steadily dropped far back with a dull effort.
