SON OF MARIAH was hustled to the front, established a clear lead into the stretch and held on despite tiring in the final sixteenth. DAVE D AND DAVE W outrun early, swung six wide into the stretch and closed ground willingly. DIAMOND FLEET raced forwardly between foes, angled in for the stretch run and stayed on. ZANY NORTHWESTERN was urged along while six wide early and weakened in the final furlong. NAPOLEON J broke sharply, chased the pacesetter while racing along the inside and faded through the stretch run. FIGHTING JUSTICE was always outrun.
