SEAHAG set the pace with good early speed while off the rail, drew off on the turn and was fully extended through the stretch. SUN VALLEY STORM was void of early speed while saving ground, improved position but was no threat to the winner. EXECUTIVELY was in a good stalking position in mid pack, ran evenly with no rally. MOOR N MOUNTAIN showed good early speed, faltered and faded. ICY LAND LADY was well placed in mid pack, had no rally. MIZZEN THE RHYTHM failed to menace. GGLAD flashed brief speed, stopped and dropped back. PRINCESS CELIA was no threat. SPRING RECITAL showed good early speed, gave way and faded. PER RULING DATED 3/12/2012 RECEIVED FROM THE OHIO RACING COMMISSION (RULING #2012-47), SEAHAG WAS DQ'D DUE TO A POSITIVE TEST.
