ACTION AT THE TOP stalked the pace with good early speed, was no match for the winner but was clearly second best. EBONY EXPRESS showed good early speed when rushed up to duel, faltered and faded. OUTLAW ACADEMY was in a good stalking position in mid pack, ran evenly with no rally. WINFER failed to menace. MCBEAN was no threat.
