MY FRIEND BERNIE stalked the pace while never far back on the outside, rallied into the stretch and was all out to get up in the final strides. SATUM (CHI) set the pace with good early speed while off the rail, led late but was outfinished to the wire. NEW YORK SOLUTION was in a good stalking position on the outside, had a late rally in the stretch and was gaining but too late. MITEY MAX WEINBERG was pinched back at the start, had a late rally in the stretch and was gaining but also too late. PUTMEUPFRONT was well placed in mid pack, had a mild late rally. DOUBLE NAUGHT SPY was unhurried early while seven wide and lost ground, also had a late rally but too late. LAZYZLOU CARSON bobbled at the start, was void of early speed, had a mild late rally. ENTICEMENT showed good early speed, faltered and faded. POWER PARTS was well placed in mid pack, had no rally. HOOTEN'S RIDGE failed to menace. GIMME GOOSEBUMPS was no threat.
