TWOSTEP PARTNER lunged at the start and then stalked the pace, rallied into the stretch on the inside and drifted out late, was fully extended to the finish. ALIAS'S N ALIBI'S set the pace with good early speed while off the rail, led to mid stretch, was steadied late while tiring but was still second best. WANNABETHEBISCUIT was void of early speed, improved position in the stretch but was no factor. NINO'S DEFENSE was well placed with good early speed, weakened in the stretch and dropped back. CHASE THE BLAZE failed to menace. PREMIER COURT showed good early speed chasing the pace, faltered and faded.
