Footnotes

SMITTEN CAT was unhurried early while saving ground, was angled out and rallied into the stretch, bore out and bothered CONSOLIDATING, creating a chain reaction, was all out to hold on late. JOSHUA'S BREAK stalked the pace while never far back, was steadied briefly when foes came out upper stretch, drifted out badly late and was outfinished to the wire. MY TWO ROSES was void of early speed, had a late rally in the stretch and was gaining but too late. ALIGIGGLES set the pace with good early speed, faltered and faded. CONSOLIDATING was in a good stalking position, rallied into the stretch, was taken up when the winner bore out, ran evenly late. FIRMLAND was unhurried early while five wide, had no rally. SMITTEN CAT WAS DISQUALIFIED FROM FIRST AND PLACE FIFTH FOR BEARING OUT IN UPPER STRETCH AND CAUSING A CHAIN REACTION.
