MARBLE CLIFF stalked the early pacesetter, made a quick move at the quarter pole and gained a clear advantage, drew off through the stretch while being ridden out. COLD TRIAL well placed and saved ground, rallied in the stretch, was no match for the winner but held place. TYPE A PERSONALITY well placed while between horses, could not gain on the winner but finished willingly. O'RIAIN never far back while three wide early, lacked a rally. POOLE OF CASH slow early, was never a factor. KEY LOW set the pace until the turn, then gave way in the stretch.
