TALE OF THE COURT stalked the pace while four wide, rallied into the stretch and wore down the leader, drew clear under constant urging. MO'S RIVERA was well placed early, rallied on the turn and drew off in upper stretch, weakened and ran evenly late. PRIVATE PREMIER set the pace with good early speed, faltered and faded. STREET LAUGH failed to menace. STARR WEST was no factor. DUE TO A JAY BIRDS HERO INJURING HIMSELF IN THE PADDOCK PRE RACE AND THEN A STARTING GATE MALFUNCTION, THE FOURTH RACE WAS DELAYED 17 MINUTES.
