Footnotes

UPTOWN GAL tracked leaders to quarter pole ,took over when ready and drew off as much the best. DENIRO'S SAINT bothered a bit at the start, taken outside while far back, rallied wide into the stretch with a mild rally for place while no match. BLAZING BLING had good speed to duel for three quarters but faltered in the drive after being hooked by the winner. SIGNIFICANT BLING within striking position for three quarters but gave way in the drive. SUGAR MARIE well placed while never far back from off the rail but faded in the stretch. NIAGARA MOON was through after a half. MAGISTRATE was through early and dropped far back quickly, lost contact but galloped out and crossed the wire.
