RIP SNORTER showed good speed to stay with winner from between horses, angled out into the stretch and came back for place. ERIN AND AVA raced evenly and lacked the late response needed in the drive. NOT ENUFF JUSTICE had speed from three wide down the backstretch but faded from the turn. PREACHER failed to menace. DAZZLE N THRILL never a threat.
