Footnotes

BORROWER was hung out four wide while close up on the first turn, made a bid for the lead on the backstretch, went clear on the final turn, drew off in the final furlong under urging. YETI OR NOT stalked the pace while saving ground to the stretch, bid inside of the winner in upper stretch, proved no match late but saved the place. NEVER FORGET was squeezed and forced to steady leaving the gate, raced between rivals in midpack on the first turn, moved closer on the backstretch, chased around the final turn, failed to rally. SMARMY saved ground racing well off the pace to the stretch, rallied entering the lane but failed to produce a late bid. REAPINGTHEREWARDS raced well back to the stretch, angled out entering the lane, did not rally. PLAY THE HERO stumbled leaving the gate, raced well back to the stretch before passing a few tired foes. RAMBLIN MIKE dueled from the two path to early on the final turn before tiring. DAKOTA'S CHOICE raced four wide on the first turn while in midpack, advanced outside rivals on the backstretch, was a forward factor to the stretch before tiring. LYNN'S VISION dueled along the rail on the first turn, was overtaken entering the backstretch and stopped after a half mile. PRINCE WAR ON vied for the lead from between rivals early, steadied midway on the first turn, dropped back quickly on the backstretch, was distanced. A claim of foul by the rider of NEVER FORGET against the winner alleging interference leaving the gate was not allowed.
