HOOOOKANDBOOK sent up three wide to vie for the lead, dueled around the turn and drew off through the stretch under good handling. THUNDER OF HOPE had good speed to duel briefly with the winner but was no match and clearly second best. DIXIE VIEW had good speed to the stretch, shortened stride approaching the furlong marker and still had enough left to hold the show spot. SKIP TOO WIN moved up from outside to contend but raced evenly in the late going. LOOKBEFOREYOULEAP raced evenly to the stretch and failed to respond in the drive. GORGEOUS PROSPECT failed to menace. ROSIE TEE was through after a half. DREAMING OF MARY was no factor. DEPUTY DONNA was through early. GREAT MILLENNIUM was off slow, rushed and steadied into the turn but no factor. STORMIN LINDA dropped back quickly. KATELYN GIRL was no threat.
