KISS ME BAMBAM was away quickly and set the pace while off the rail, responded when challenged on the turn, drew off in upper stretch and was fully extended to the wire. G T'S GONE DANCING was in a good stalking position while saving ground, had a late rally and was gaining but too late. STRAIGHTCASHHOMEY was well placed while four wide, rallied on the turn and dueled, failed to sustain the bid and ran evenly late. ROBINS GOLDEN GIRL stalked the pace while five wide, ran evenly with no rally. L. A. EXPRESS showed good early speed, gave way and dropped back. MOUNTAIN OF HONEY was void of early speed, improved position but was no threat. ROYAL ISLAND was well placed on the inside, had no rally. TREVOR'S FAST CAT failed to menace. DUE CONSIDERATION was pinched back at the start, was no factor. HERE COMES DESSERT was no factor. KATIE'S LADY flashed brief speed before stopping.
