Footnotes

RED DEFENSE settled leaving the gate, advanced four wide around the turn and into the stretch, closed smartly from the outside, reached front past sixteenth marker and drew clear. NOFTY tracked pacesetter while outside foe then between horses, continued two wide into the lane, loomed between rivals past sixteenth and finished well inside winner. THUNDER OF ZION broke alertly and sped to the front, angled over and retained clear advantage into the stretch, was overtaken past sixteenth marker but safely held third. BLUE JAY ATTACK was slow into stride then steered to inside, chased along the rail, swung back out around the turn, came three wide into lane, came out further and finished willingly. JEFFREY'S GROOVE settled early, advanced three wide into and on the turn, continued off the rail but failed to sustain effort in the drive. MY SUMMER SLEW broke in and bumped rival, chased from between rivals then three wide, later was guided to the rail but failed to menace. WARREN'S DR. YANG was bumped leaving the gate, raced between foes then two wide, came out some in upper stretch but was no late threat. SHU BIZ DANNY showed brief early foot, dropped back around the turn and into the stretch and weakened. SUANCES CANDY reserved along the rail, moved up inside, in tight and forced to check off heels early on the turn, was shuffled back and

never recovered.
