Footnotes

D J DAVE sped to the early lead, set the pace along the inside, kicked clear on the turn and held under left handed urging. BESAME SUANCES stalked the pace inside, came off the rail in midstretch and held second. CAT MEETING off a bit slowly, pulled his way between horses then chased just off the rail leaving the backstretch, came three deep into the stretch, drifted in and was edged for the place. ASKINGFORTROUBLE also pulled between horses then chased outside a rival or off the rail, came three wide into the stretch and bested the rest. UNUSUAL BEAM broke a bit slowly, settled just off the rail then inside on the turn, came out into the stretch and improved position. JACO RED had speed to stalked the pace three deep then outside a rival on the turn and weakened. WILD SIDE STORY broke slowly, moved up inside to chase the pace, came out leaving the turn and into the stretch and did not rally. WARREN'S CLOSER between foes early, chased five wide then four wide, angled in on the turn, came out into the stretch and was not a threat. TRIUMVIRATE pulled his way between horses to force then stalked the pace, steadied to the turn, angled to the inside on the bend and weakened.

SUPERSONIC HEAT steadied between foes after the start, settled off the rail then outside a rival, came out some in the stretch and failed to menace. SCOOTER'S STAR pulled between horses to chase the pace, dropped back on the turn, gave way and was eased in the stretch. JOE DOGGS also pulled between horses to chase the pace, dropped back outside into and on the turn, gave way and was eased in the drive.
