## Footnotes

PORFIDO (CHI) unhurried inside then a bit off the rail, came out into the stretch and in upper stretch and rallied under left handed urging to get up nearing the wire. SLAMMER TIME saved ground chasing the pace, awaited room into the stretch, steadied off heels and came out in midstretch, rallied between horses, put a head in front in deep stretch and was edged late. MR. MAKE BELIEVE four wide into the first turn, chased outside, went three deep on the second turn and four wide into the stretch and finished well. EUROGLIDE stalked between horses then bid between foes leaving the backstretch, tracked off the rail on the second turn, came out three deep into the stretch, bid again alongside DONATO in the drive and continued willingly the wire. MEMEN (IRE) unhurried a bit off the rail then inside, came out into the stretch and again in upper stretch and found his best stride late. SCORPION TIME bumped at the start, stalked between horses, came out some in the stretch and lacked the needed rally. DEADLY CATCH broke in and bumped a rival, angled in and

stalked inside, came out for room into the stretch, was in tight off heels in midstretch, angled in again and could not offer the necessary response. GOLD MEDALLION five wide into the first turn, chased outside then alongside a rival, angled to the inside into the stretch, came out for room between foes in the drive and lacked the needed rally. DONATO had speed outside then dueled between foes, lugged out some on the backstretch, battled outside a rival on the second turn and off the rail in midstretch and weakened in the final furlong. SMOKE'N AL angled in and dueled inside, fought back on the second turn and into the stretch, then weakened. MOMENT OF WEAKNESS (IRE) prompted the pace three deep on the first turn, stalked outside on the backstretch and second turn, came four wide into the stretch and also weakened. HONOUR THE DEPUTY bumped and squeezed at the start, settled outside a rival or a bit off the rail, came four wide into the stretch, drifted in and was not a threat.
