FLASHY DAME stalked outside a rival then bid alongside a foe and took a short lead on the backstretch, inched away on the second turn, kicked clear and held under left handed urging. DOLPHIN SHORTS chased a bit off the rail, went outside a rival on the second turn, came out some into the stretch, drifted in a bit in the drive and was clearly second best. HOLIDAY N NEWPORT pulled her way to the early lead, drifted out into the first turn then angled in and set the pace inside on that turn, dueled inside on the backstretch, came out into the stretch and weakened but bested the rest. DERBY MEMO settled inside then a bit off the rail, split rivals on the second turn and improved position in the stretch. WILLETTA chased just off the inside, came out on the second turn and four wide into the stretch and did not rally. TIZ ANNA angled in and chased a bit off the fence, found the inside on the second turn, continued inside and lacked the needed response. JOLLY GREEN BEAN chased outside a rival, came three wide into the stretch, gave way and was eased in the lane. MISS JUDGED saved ground stalking the pace, dropped back on the second turn, also gave way and was eased. DIOCESAN POLICY broke slowly, went four wide then three deep on the first turn, angled in some and dropped back on the second turn, had nothing left for the stretch and also was eased.
