**Footnotes**

SURFCUP broke slowly and was bumped, pulled and came out into the first turn, chased outside a rival then between foes midway on the backstretch, continued alongside a foe into the second turn, came out leaving that bend and four wide into the stretch, rallied under urging outside foes in deep stretch and got up late. ROB'S PAL chased outside a rival then between foes on the backstretch and into the second turn, continued a bit off the rail leaving that turn, came out some in the stretch, bid between horses in deep stretch, put a head in front late when brushed by a rival and was edged on the wire. GENTLEMEN PETE angled in and chased inside, split horses on the second turn, angled in some in the stretch, bid between horses in deep stretch, brushed with the runner-up in late stretch and continued willingly. CITY STATE pulled between horses then stalked off the rail, bid alongside a rival on the backstretch and second turn and into the stretch, gained a short advantage in midstretch, was between horses in deep stretch and was outfinished. REAL HEAT sent inside to the early lead, dueled on the backstretch and second turn, fought back when headed in the drive and weakened late. O WILD WEST WIND a bit slow to begin, drifted out into the first turn, went up three deep on the backstretch, continued outside on the second turn and into the stretch and did not rally. WARREN'S CLIFF S. saved ground stalking the pace, fell back on the second turn and weakened. ALYDIDIT broke out a bit, was sent along outside then stalked alongside a rival, continued three deep on the backstretch and second turn and weakened in the stretch. A claim of foul by the rider of the runner-up against the winner for alleged interference in deep stretch was not allowed by the stewards, who ruled the videotape failed to substantiate the claim.
