**Footnotes**

TOO FAST TO PASS stalked a bit off the rail then inside on the turn, came out into the stretch and rallied under urging to get up three wide on the wire. DERRINGER had speed between horses then dueled outside a rival, took a short lead on the turn, fought back when headed in the stretch, regained the advantage a sixteenth out and was edged between foes on the line. MONEY CANNON sent inside to duel for the lead, fought back on the turn and through the stretch and went willingly to the end. KAFISTER had speed outside foes then stalked off the rail or between horses, continued outside the winner on the turn and three deep into the stretch and also went on willingly through the drive. BOTCH settled off the pace inside, came out into the stretch and again in upper stretch and found his best stride late outside. ONE FIRM CAT unhurried off the rail early, angled in and saved ground thereafter and lacked the needed rally. TAHOE FLASH stalked outside then off the rail, came three wide into the stretch and weakened. MAJOR TRUTH had speed five wide then dropped back outside or off the rail on the backstretch and turn, came a bit wide into the stretch and lacked a further response.
