BUBBLE GUM ALLEY lacked good early speed, came two wide to the stretch and came on for the show without being a factor. SCARLET BEDONIA dueled from the outside to the quarter pole and gave out. MAMMA MIA lacked good early speed then saved ground to no avail. HOLY DEUCE had no speed.
