GO MALABAR GOLD broke in stride and set the pace in hand, responded once set down in the stretch and drew clear impressively. UP YOUR WAGER was permitted to settle early, saved ground into the lane and finished in a rally. HOUSE OF CRYSTAL stalked the winner three wide to the stretch, had her best bid into the lane but flattened out. NAVY LASS prompted the winner two wide to the stretch and slackened. GLASS OF RED stalked the pace from the rail for a half mile and weakened. CHERYL'S SIDEKICK was shuffled back between horses in the opening stages and dropped well out of it while racing greenly then found her stride in the stretch but never reached contention. ALPINE LADY settled early, raced three wide on the turn and failed to respond. CALIFORNIA LAURA broke slow and was always outrun. DOUBLON CITY had no speed.
