ANN T was quickly in front and set all of the pace, drew off to a long lead into the stretch and was kept to her task to the line. RAINYSBELLE was permitted to settle early and raced off the rail to the backstretch, came three wide into the stretch and finished steadily but was never a threat to the winner. CEE MY TIZZY RUN tracked the winner three wide for six furlongs and weakened. BRAVE CINDERELLA settled early then saved ground to no avail. SKIN TO WIN stalked the winner two wide to the stretch and came up empty. CHULA CELIA lacked early speed then drifted four wide on the second turn and never reached contention. STEVIE'S GIRL saved ground throughout but was always outrun. MOONLIGHT GOLD showed no speed then was eased in the stretch but walked off.
