**Footnotes**

LADY OF JACKSON was hustled from the gate to gain position early, stalked WICKED COUNTY for the lead, moved up to that rival steadily on the turn, took command once in the stretch, drew clear near the furlong pole and held driving. HIGH INTEREST settled early inside a wall of horses, remained inside on the turn and finished steadily. WICKED COUNTY broke quickly to make the lead and crossed to the rail, was headed by the winner in the upper stretch and slackened. BELLA GIADA was forwardly placed between horses to the turn then lacked a solid closing response. CLASSY BAY lacked any early speed, saved ground and passed tiring horses. TAHOE DREAM was never a factor. ANGEL'S LAW was well placed early outside a four horse spread, edged nearer the rail into the stretch but had no response and was not persevered with late. SHEEN FALLS settled early, then had no response while three wide on the turn.
