PLEASANT THUNDER stalked the leaders from the rail to the second turn, rallied two wide then swung out four wide into the stretch, continued to respond through the drive and was up late. QUIET RUMOR dueled for the lead outside of COURT SEEKER to the second turn, continued to do battle with that one to mid stretch, had the lead late but could not stall the winner. MISSILE TONE had no speed and settled to the half, bid inside on the second turn then shifted out but finished evenly in the final furlong. POURMEADouble was allowed to settle to the second turn, came two wide to the stretch then also lacked the needed late response. MY PEPPERMINTPATY was also settled while three wide to the second turn, remained three wide then swung out into the stretch but finished evenly in the drive. COSMIC LADY broke slow then hurried to join the leaders three wide on the first turn, was a pace factor three wide to the stretch then weakened. COURT SEEKER dueled for the lead from the rail to the stretch, remained stubborn to mid stretch then stopped suddenly in the final furlong.
