Footnotes

DEMON WARLOCK was permitted to settle within striking distance early, advanced outside SEMPAL on the turn, was able to avoid the spill at the five sixteenths pole, then rallied between horses in the lane, was caught in tight quarters nearing the finish, bumping with SEMPAL, then got up in the final strides. DANZHOUND set all of the pace under pressure from off the rail, drifted in late and lost command. SANTANO dueled outside DANZHOUND throughout and finished gamely. CONTEXTE lagged early, was able to avoid the accident on the turn, came to the outside and closed boldly. SEMPAL stalked the pace from the inside, checked but was also able to avoid the spill on the turn, tried to rally from the rail in the lane, was caught in tight quarters late, was bumped and knocked into the inside rail then steadied from contention. RAINMAN'S REQUEST was not asked for speed early, saved ground and was gaining late. PERFECT JUDGMENT dueled between the leaders early, was slipped back into the turn but clipped heels and fell. DANCE WITH PRIDE was permitted to settle early, steadied sharply and was bumped by GHOSTLY SMILE after that horse had fallen near the five sixteenths and was pulled up. GHOSTLY SMILE (NZ) staked the pace from the outside, was unable to avoid PERFECT JUDGMENT on the turn and fell. The stewards conducted a pair of inquiries into the race. They could place no blame in the incident on the turn concerning the spill, but for interference in the deep stretch, DANZHOUND

was disqualified and placed fifth.
