VERMONT APPEAL tracked the dueling leaders from the outset, offered her bide two wide on the turn to gain command once in the stretch, drew clear while drifting out a bit and held driving. KISSMEKISSMEQUICK raced unhurried early, came through inside on the turn to reach contention then continued to close without bothering the winner. BEACHHOUSE lacked good early speed, was forced four wide on the turn and finished well but too late. NANCY DOLLYGIRL dueled from the rail to mid turn and gave out. MIKAY AS LADY dueled outside NANCY DOLLYGIRL, took command on the turn but gave way to the winner into the stretch and faltered steadily. TONYANNA was void of early speed, came four wide to the stretch and passed tiring horses. FESTIVAL OF FUN was permitted to settle early then failed to respond while three wide on the turn. CLEVER RED HEAD raced in mid pack early, was three wide on the turn and failed to rally. FIREFLOWER broke a bit slow and was slow to settle then raced up boldly from the rail in the opening quarter, was boxed and steadied into the turn and fell from contention. COMPELLING WIND was never a factor. LITTLE HARDY was always outrun.
