**Footnotes**

FOX IN THE HOUSE broke in stride and dueled outside HYPER SPEED HOWARD to the stretch, disposed of that rival and drew clear while being kept to his task. BERT'S LAW lacked good early speed, came two wide to the stretch and gained the place without bothering the winner. HYPER SPEED HOWARD dueled inside the winner to the head of the lane and slackened. HERITAGE HARLEY flashed brief speed from the outside, weakened then checked off the horse that bolted at the furlong pole. EARL OF FOXPOINT stalked the leaders early, came three wide into the lane, ducked out sharply while trying to bolt at the furlong pole and unseated his rider. A stewards inquiry into the incident concerning EARL OF FOXPOINT resulted in no action being taken.
