HOUSE OF CRYSTAL was brushed by ENSIGN MORANSKI at the start then raced just behind the leaders to the turn, remained inside and pounced on HIGHLY ATTACHED when that one left an opening inside, took over in mid stretch and was under steady pressure to the wire. YOUNG AND FRESH stalked the pace outside rivals to the turn, was fanned four wide to the stretch, responded to pressure to mid stretch then was outfinished but grabbed the place late. HIGHLY ATTACHED had good speed and dueled to the turn, left room inside for the winner into the stretch, was collared by that one in mid stretch then finished steadily but missed the place. ENSIGN MORANSKI was bumped by JOJO'S JUSTICE at the start then stalked the leaders but was in tight off heels and raced in check to the half mile pole, came two wide to the stretch, had to angle out in mid stretch for room then had a mild late bid once clear. JOJO'S JUSTICE broke out and bumped ENSIGN MORANSKI at the start, dueled for the lead three wide to the stretch then tired.
