LOOKN FOR THE LORD broke in stride and alternated on the lead inside BABCOCK LAKE throughout, took a short lead into the stretch and held determinedly. BABCOCK LAKE vied outside the winner throughout but was outdueled to the line. FULL POWER AHEAD was void of any early speed, came through inside on the turn and finished in a steady rally. DEFENSIVE MOVE raced up inside to the two leaders in the opening quarter, slipped back slightly into the turn but went gamely to the line. MR. NEGOTIATOR was permitted to settle early, raced four wide on the turn and failed to rally. GOLD LABEL stalked the lead early from the outside, raced three wide to the stretch and came up empty. RAVE RAVE RAVE showed little. RAMOS FIZZ had no speed.
