Footnotes

RAILROAD raced up from the outside into the first turn to prompt the pace three wide, moved to challenge WILD BUDDY two wide on the second turn, took command near the quarter pole, drew to a long lead at the furlong pole and held driving. CLIPPERDOWN (IRE) tracked the pace under a snug hold three wide early, remained under a hold on the backstretch, came three wide to the stretch and finished steadily. CAPITANO raced unhurried early from off the rail, advanced three wide into the lane but lacked the needed response. REAL TEMPTATION steadied off heels into the first turn and fell back, raced three wide on the second turn and closed late but never reached serious contention. MARBURY lagged early then had no rally from off the rail on the second turn. WILD BUDDY set the pace outside COURT'S IN SESSION early, held a clear lead into the second turn but gradually gave way from the inside nearing the stretch. MCCANN'S MOJAVE raced unhurried from the rail early, moved off the rail on the second turn behind traffic and failed to respond. COURT'S IN SESSION pressed the pace from the inside to the second turn and gave out. CAUSE TO BELIEVE raced close up early outside CLIPPERDOWN but had no response when called upon. MY CREED showed little. GRAFTON saved ground to no avail.
