JOST VAN DYKE well placed and between rivals, moved to position through the turn, bid just outside the pace setter, then drew off and was ridden out. GHOST DANCE stalked the early pace outside, moved up through the turn to bid three wide into the stretch, then closed willingly to get up for the place while no threat to the winner. DANCINGWITHBIGRON mid pack and between rivals, gained contention through the turn, came four wide to bid into the stretch, veered out in the lane while gaining. SIR SOMERSET well back and outside, fanned five wide to bid into the stretch, then closed willingly through the lane to get up for a share. JACK'S TIGER passed tiring rivals. OUR FAMILY AFFAIR never far back and outside, moved up through the turn, bid five wide into the stretch, then was forced out by a rival and could not gain. NICE TO MEET ME mid pack and on the rail, gained a striking position through the turn, then had a mild stretch gain. DESERT ALLEY well placed inside, faltered in the drive. REDNECK RICHIE set the early pace three wide and faded after a half. MONDOVI was never involved. STRAITUPCASHHOMEY showed little. FOR INSTANCE was no factor. A CLAIM OF FOUL LODGED BY THE RIDER OF OUR FAMILY AFFAIR AGAINST THE RIDER OF DANCINGWITHBIGRON WAS ALLOWED
