BEAU NAMED SUE was settled along the inside in the opening half, angled off the inside entering the backstretch, quickly drew into contention with a sharp four wide move entering upper stretch and took charge in the final stages, pulling clear under firm encouragement. DAWN RAIDER, allowed to settle near the inside racing to the backstretch, saved ground to upper stretch, came through to challenge inside foes when presented an opening in the lane but was only second best. LITTLE WAGON broke outwards bumping DEPUTY TICE, was held up off that foe in the opening stages, switched outside on the backstretch while readily drawing into contention, exchanged several more bumps with DEPUTY TICE approaching the far turn, continued with a three wide advance to wrest brief command in upper stretch but proved no match when confronted by the winner. DEPUTY TICE, bumped at the start, was quickly righted to gain a tracking position racing just off the leaders in the opening half, was bumped approaching the far turn, briefly awaited an opening nearing upper stretch, angled out four deep leaving midstretch and continued willingly. KON KRETE KID, allowed to settle in early stages, swung five wide racing into upper stretch while gathering momentum and made some belated progress. BOLD BENGIE was urged to the fore from the break, dueled for command along the rail racing to the far turn and emptied out in the drive. IZA CHILI BEAN angled inwards while gaining terms with the leader in the opening stages, prompted the pace outside that foe racing to the far turn and gave way abruptly.
