Footnotes

OBJECTION showed good early speed while racing just off the inside and drew off in the final stages to be well clear under steady handling. R PERKS was allowed to settle early, saved ground and finished second best. MISS DARLA was off a step slow, moved up four wide in the lane and gained ground willingly in the final stages. THELATESTTHING was hustled along from the inside to press the pace and tired. ENDURING ANGEL dropped back early, moved up four wide into the upper stretch and never was a factor. CASCADIAN MATT pressed the pace from the outside and gave way. ELEGANT AFFAIR was slow early and never menaced. KEY AFFAIR failed to sustain a bid.
