PHILIPPIS rated nicely on the lead, turned back a challenged through the second turn, gained a clear lead in the stretch, then drew off under steady pressure. REVEAL rated back on the inside, raced boxed through the second turn, was blocked into the stretch, got through between rivals three wide in the stretch, then closed willingly to get up for the place while no threat to the winner. LADY JORDAN vied for the early lead outside and weakened in the drive. CHECKOUTMYMAN well placed and off the rail, moved to position three wide through the turn, drifted out into the stretch and faded. SILVER CASE was outrun.
