Footnotes

BLUMIN BEAUTY tracked the first flight along the inside within easy striking distance, came through to challenge when presented an opening in upper stretch, quickly took over and held sway to the end under firm encouragement. MARSH MARIGOLD angled inwards to track the leaders three deep in second flight, dropped over to the rail midway through the bend, came inside foes to challenge and closed the gap on the winner to the end. SHOT OF SILVER was reserved near the inside in the opening stages, shifted out nearing the lane to split foes three wide in upper stretch and improving her position willingly to the end. SMOKIN' SPIRIT went readily to the fore, set the pace to upper stretch, drifted out from the rail in the lane and steadily faded from contention. DEVIL NOT ME, allowed to settle outside foes in the opening stages, was fanned six wide racing into upper stretch and made some mild progress. JETTIN TWISTER, caught four wide disputing the pace in the opening half, gave way in the drive. HOT SAX tracked the leaders unhurried in early stages but never seriously menaced. SPARKLING ENDEAVOR chased the pacesetter three wide between foes into the bend and emptied out in upper stretch. OUT OF SERVICE was urged to secure a forward placing but dropped out early. JANE'S GOLD tracked in second flight between foes, was pulled up entering the turn, then walked off the course under her own power.
