**Footnotes**

CACHEMASSA CREEK tracked the pace inside, angled out into the second turn and moved up, came three wide to bid into the stretch, then made a steady gain and edged ahead in the final strides. THE QUINSTER set the pace on the inside, gained a clear lead into the second turn, increased his margin into the stretch, then was outfinished. COTSWOLD HILLS mid pack and inside, gained a striking position through the second turn, came through inside of rivals into the stretch and held the show. VINI VIDI VINCI void of speed, closed fast through the lane to get up for a share inside. SHRYOCK passed tiring rivals. TINUILCO (CHI) vied for the early lead outside and had no rally. MACK'S MONARCH well placed and outside, angled in into the second turn, then had no stretch rally. HOWARD COUNTY HANK was no factor. ROOT RIVER KID well placed and outside, faded after a half.
