**Footnotes**

UNLAWFUL DETAINER chased the early pace on the rail, angled out into the stretch to bid, was blocked at the three sixteenth pole, then altered out four wide, was brushed by a rival and drove clear in the final strides. GRUBBS stalked the early pace three wide, fanned four wide to bid into the stretch, dueled with PARAGRIN, shook loose of that one, drifted out to brush the winner and was outfinished. MISS AFFAIR well placed and outside, fanned five wide for the drive, then lacked the needed late response. PARAGRIN vied for the early lead from between rivals, gained a short lead into the stretch, then dueled with GRUBBS in the lane and weakened inside. I NEED A BALEOUT broke a step slowly, then steadily drifted out and was no factor. PRINCE RAJ rushed up to set the early pace while hard to rate, then faded nearing the lane.
