YODELIN' ANGEL pressed the pace, gained command nearing the turn and held gamely to be clear under all out pressure. CASSIDILLY was unhurried early, moved up four wide in the lane and finished second best. VALARI was unhurried early, saved ground and made a mild late gain. CHERRYFUL LADY vied for the lead and weakened. MISS LA PRISS was slow early and never threatened. DANGEROUS GHOST stalked the pace from the outside, raced four wide into the upper stretch and never was a factor. LE CHOT JOLIE settled off the early pace, raced four deep in the lane and had no response. R CHARMED AFFAIR failed to sustain a bid.
