Footnotes

BATON ON FIRE stalked the pace, saved ground and finished gamely to prevail under all out pressure. ROBBIE'S EXPRESS settled off the early pace, moved up four wide at the eighth pole and finished gamely to just miss. BACKTRACK was unhurried early, moved up five wide into the stretch and made a mild late gain. ILIKECHOCOLATEMILK settled off the early pace, moved up four wide into the upper stretch and had no late response. BRAVO PRADO set all the pace along the inside and faltered in the drive. TIGERSTARK was slow early and never threatened. FORCHTENBERG failed to sustain a bid. WIRELESS MACHO pressed the pace and faded.
