**Footnotes**

THE QUINNSTER, bumped by EMAIL ALERT at the start, was quickly righted to join the pace, dueled for command along the rail racing into the bend, shook clear nearing upper stretch, then steadily widened his advantage under pressure. ROOT RIVER KID broke in, bumped EMAIL ALERT, was collected off that foe, altered course to the inside racing through the backstretch, switched off the inside to bid three deep in upper stretch, couldn't menace the winner but proved best of the others. TIOGA CROSSING, forwardly placed between foes racing to the bend, angled to the inside on the turn and finished evenly late. HUEBAKER tracked the first flight from the outside racing into the turn and made some mild progress to late stages. EMAIL ALERT, bumped at the start and forced into the eventual winner at the start, was steadied off ROOT RIVER KID approaching the turn, then continued near the inside to late stages while steadily improving position. EARLY OUT EDDIE prompted the pace three wide between foes racing to the turn, then gave way in the drive. KILABUCK bobbled at the start, lost some position to the field and never gained contention. WILLOW PARISH never seriously menaced. NORTHERN VICEROY was a brief factor racing four wide to the turn, but retreated after a half. FOLLOWING THE RACE THE STEWARDS CONDUCTED AN INQUIRY INTO THE START AND DISQUALIFIED ROOT RIVER KID, PLACING HIM FIFTH FOR INTERFERENCE.
