All other purse monies paid corresponding with purse schedule in Condition Book. Weights: Three-year-olds, 118 lbs.; Older, 123 lbs. Non-winners of \$15,000 at one mile or over in 2012 allowed 3 lbs.; \$10,000 at a mile or over in 2012, 5 lbs.; \$10,000 at a mile or over in 2011-2012, 7 lbs. (Maiden, Claiming and Starter races not considered in allowances). HIGH WEIGHTS PREFERRED (On the Scale). (Winners Preferred). A trophy will be presented to the winner owner. Nominations closed Thursday, June 21 with 17. (If management deems it inadvisable to run this race on the Turf, it will be run at a distance of 1Mile and 1/16 on the main track.). (S)

TUBBY TIME well back and off the rail, looped rivals three wide through the second turn, came four wide to bid into the stretch, then made a steady gain and drove clear late. COCONINO SLIM set the pace on the inside while pulling, shook clear into the stretch, then could not match the winners stride late and held the place safe. MACK'S BLACKHAWK well placed and pulling, angled out to move up three wide through the second turn, bid on that path into the stretch and flattened out. SAMENDRA void of speed, angled out three wide into the second turn, fanned widest into the stretch and lacked the needed late kick. BIZET well placed and inside, gained a striking position through the second turn, came through inside of rivals into the stretch and lacked a late response. JAIVAL stalked the pace on the outside, moved up to bid just outside of that one, then faded the final furlong. HERE COMES HENRY ran evenly. EURASIAN showed little. WOLSFELD WOODS well placed and three wide, was boxed and pulling down the backstretch, then stopped after three quarters.
