### Footnotes

CLAXTON well back and outside, looped rivals three wide through the second turn, came five wide to bid into the stretch, then made a steady gain and drew off late. TECHNICAL EXPRESS chased the early pace outside, took command at the half mile pole, increased his margin in the stretch and was outfinished. ILIKECHOCOLATEMILK started awkwardly, angled in soon after start, moved up through the second turn, then made a steady gain in the lane to gain the show while no threat to the top two. SIR TRICKY well placed and inside, angled out into the stretch, then ran evenly in the lane. STRIKE IT RITZ gained a striking position inside and faded in the drive. CASE IN POINT well placed, had no rally. FULL HORSE POWER set the early pace off the rail and faltered. TIMETOBOOK showed little.
