BEAR ISLAND stalked the early pace outside, bid three wide into the stretch, then gained a clear lead the final furlong and drew off under brisk handling. L G SUPREM tracked the pace on the inside, moved up through the turn and angled out to bid four wide, then closed willingly through the lane to get up for the place while no threat to the winner. LIONS COURT well placed and outside, gained position through the turn, came four wide to bid and weakened late. AFFIRMED CURE mid pack and inside, moved up through the turn, came through inside of rivals into the stretch, then closed well to gain a share. JACK WINTER improved position. APPEALS THE DEAL vied for the early lead from between rivals, then faded the final furlong. SLYDING BY set the early pace inside and faded the final furlong. DEMIDOFFS PROSPECT ran evenly. R J TRUMPS THE SYN showed little. RAMOS was never involved.
